#### **ORDER:**

The Director General, Centre for Good Governance, in his letter read above has informed that the Centre for Good Governance was a part of Dr. Marri Chenna Reddy Human Resource Development Institute at the time of its inception. Subsequently, it was bifurcated from Dr. Dr. Marri Chenna Reddy Human Resource Development Institute and was constituted as a separate Society with the Hon'ble Chief Minister as Chairman. Centre for Good Governance has also developed a number of e-Governance tools which are being used by different departments and regular training programmes are being conducted by the Centre for Good Governance, to train Government Officers in the use of these e-tools.

- 2. The Director General, Centre for Good Governance has further stated that due to bifurcation of the Centre for Good Governance from Dr. Dr. Marri Chenna Reddy Human Resource Development Institute, Centre for Good Governance has no longer the status of a Training Institution though the Centre for Good Governance has been recognized as an Institution of Excellence in Scientific and Industrial Research in the G.O. first read above. The Director General, Centre for Good Governance has therefore requested Government to recognize the Centre for Good Governance as a training institution in the area of Governance Reforms and e-Governance.
- 3. Government, after careful examination of the matter and in continuation of the orders issued in the G.O. first read above, hereby recognize the Centre for Good Governance, as a Training Institution in the area of Governance Reforms and e-Governance.
- 4. This order issues with the concurrence of the Finance Department vide their U. O. No. 19711/422/A2/Expr. GAD-I/08, Dt.05.07.2008.
